Michelle Obradovic was educated by the Sisters of Notre Dame de Namur at Trinity College in Washington D.C., is a graduate of Cumberland School of Law and holds an LL.M. from Pepperdine University, Straus Institute for Dispute Resolution, a Certificate from Harvard University and a Certificate from the National Criminal Defense College.

Michelle clerked for Judge Michael F. Bolin, Probate Court of Jefferson County (now a member of the Alabama Supreme Court) and Senior Judge Edward S. Smith, (dec.) U.S. Court of Appeals Federal Circuit, Washington, DC and for the 104th Congress, United States Senate Judiciary Committee, Democratic Minority Subcommittee on Terrorism, Technology and Government Information, Senators Herbert H. Kohl (D-WI), Patrick J. Leahy (D-VT), and Dianne Feinstein (D-CA).

Michelle is licensed to practice law in Alabama and is the owner of Wise Resolution, LLC[®]. She is a Fellow of the International Academy of Mediators, a member of Arbitral Women and a Founding Member of Mediators Beyond Borders. She has mediated in excess of 2300 commercial cases and co-medicated 145 mass torts, class actions and MDLs locally, nationally and internationally.

Michelle is the Court Mediator for the 10th Judicial Circuit and directs the Court Mediation Project for Jefferson County, Alabama. The Project coordinates mediators with the specific needs of each Judge's docket and provides dispute resolution training to attorneys and judges from across the state. New mediators are paired with mediation mentors and progress in their assignments from basic small claims cases to complex litigation. The Project resolves in excess of 400 small claims cases per year, approximately 100 ad valorem tax cases per year, over 1300 criminal municipal appeals and specially selected cases involving violent felonies. A mediation pilot in Domestic Relations Court is currently underway for 2011.

Michelle has been an Adjunct Associate Professor of Law since 2002 teaching Mediation Advocacy and Mediation Practice and Process at Samford University's Cumberland School of Law. She is the Coach of Cumberland's ABA Representation in Mediation National Teams; including the 2005 National Champions who went on to successfully compete in Paris, France. She has lectured at Cambridge University, England and teaches Criminal Law, Criminal Procedure I and II, Evidence, Interviewing, Counseling and Negotiation, Justice Theory, Trial Advocacy and Mediation at Birmingham School of Law.
